What is TherAssist?

TherAssist version 7.5 is an administrative, scheduling, documentation, and integrated billing solution for medical offices and healthcare facilities of any size. TherAssist applications are designed to maximize efficiency for both administrative and clinical staff, centralize multisite operations, and increase reimbursements. TherAssist applications are available for use in LAN, WAN and enterprise configurations or via the Internet through our ASP delivery model.

What is an ASP (Application Service Provider)?

An ASP, or Application Service Provider, is a company that provides its customers with remote access to applications hosted in a professionally managed data center. Customers can generally access these applications over the Internet or via dedicated leased lines, paying a single monthly per-user fee that covers all the costs associated with accessing, supporting, and upgrading the applications. 
